PURPOSE

The Military Affairs Committee (MAC) is a committee of the Greater Cheyenne Chamber of Commerce. Its purpose is to maintain a harmonious and productive relationship between the community and all military units in the area. Its main focus is troop support. MAC is governed by an Executive Board.

The MAC Executive Board is composed of a Chairman, Chairman-elect and six board members. The immediate past Chairman is an ex-officio member of the Executive Board. The six board members serve three-year terms with one-third of the terms expiring each year. Two new members are selected each year by the present executive board. Commanders of the four military entities (20AF, 90SW, WY Military Dept, & Naval Reserve Center), along with AFA and ESGR representatives, will report at MIL MAC and MAC Luncheons rather than Board meetings. The Executive Board selects the MAC Chairman and Chairman-elect each October with the approval of the Chamber Chairman Elect and the Board of Directors. The Executive Board meets at the call of the Chairman. All Executive Board members will chair a Sub-committee to ensure accountability for the activities.

Dues for 2010 MAC members are \$100.00. Dues cover program costs, troop support and one decal. Meal costs for quarterly meetings, Thunderbird Dinner, Governor's Receptions, Military Appreciation Day at Ribfest and other MAC meals are covered by the member. Members can choose to pay the cost at each function or pay at the beginning of the year at a discounted rate. Any member who RSVPs for an event and does not attend will be billed for the amount. Active duty military participants will pay for their meals each time they attend a luncheon or other activity.

All appointments to the MAC are for one-year terms effective January first. The retention of members for additional terms is necessary to provide continuity on the committee. Individuals selected to return will be chosen from those who demonstrate a genuine interest in active participation in, and support of the committee and military events. Members are expected to attend the quarterly meetings. Members are also encouraged to participate with military in the community life.

A calendar of events and committee chart along with the budget are included in this booklet. Note the events and dates on your personal calendar and plan to attend. Sub-committee Chairmen will need help with the many events, so contact the Chairman of the committee(s) where you want to be active. Some restricted funds remaining at the close of the fiscal year are carried over to the next year, most will be returned to the general fund of the Chamber.
